**LOCAL LAW NO. 1- 2013**

**TITLE: "A Local Law to Amend Chapter 155 of the Code of the Inc. Village of Manorhaven – Board of Zoning and Appeals"**

BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE INC. VILLAGE OF MANORHAVEN AS FOLLOWS:

**FIRST: Amendment to Chapter 155 of the Code.**

§155-60(A) of the code is amended as set forth herein.

Repeal subdivision (1) and replace with the following:

- (1) There shall be a Board of Zoning and Appeals of seven members pursuant to the provisions of the Village Law. The Board of Zoning and Appeals in existence on the effective date of this chapter shall continue. Members of the Board of Zoning and Appeals shall reside within the Village of Manorhaven.

**SECOND: Separability.**

If any section, sub-section, sentence, clause or phrase of this local law is for any reason held invalid or unconstitutional by decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this local law.

**THIRD: Effective Date.**

This act shall take effect immediately upon filing with the Secretary of State as provided by law.

**LOCAL LAW NO. 2-2013**

**TITLE: "A Local Law to Amend Chapter 147 of the Code of the Inc. Village of Manorhaven – Vehicles and Traffic – Schedule V: Stop Intersections"**

BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE INC. VILLAGE OF MANORHAVEN AS FOLLOWS:

FIRST:     **Amendment to Chapter 147 of the Code.**

§147-41 of the code is amended as set forth herein.

The following intersections shall be designated as "Stop" intersections, in accordance with the provisions of Village Code §147-08:

- A) The Corner of West Drive and Orchard Beach Blvd;
- B) The Corner of Mohegan Avenue and Sintsink Drive West;
- C) The Northeast Corner of Dunes Lane and Cornwall Lane;
- D) The West Corner of Sintsink Drive East and Secatogue Avenue.

SECOND:   **Separability.**

If any section, sub-section, sentence, clause or phrase of this local law is for any reason held invalid or unconstitutional by decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this local law.

THIRD:     **Effective Date.**

This act shall take effect immediately upon filing with the Secretary of State as provided by law.
