Tax Warrant: Village Attorney Casolaro explained the Tax Warrant is a required document for which the Mayor must sign and the Clerk to keep on file.

Firwood Road Retaining Wall Survey: Dvirka and Bartilucci, the Village Engineers have visited the site of the retaining wall located at the dead end of Firwood Road. Before any determination is made they highly recommend the Village obtaining a property survey and a topographical survey of the wall in question. We have a quote from AK Associates for \$1450 for both the property line and the topographical survey.

Mayor Giunta made a motion to approve the proposed quote from AK Associates; the vote was unanimous to approve \$1450 for property line/topographical survey.
