**RESOLUTION #15 - 2018-2019 - APPOINTMENT OF SHARON NATALIE ABRAMSKI  
AS A MARRIAGE OFFICER**

**WHEREAS**, pursuant to Article 3, Section 11-c of the New York State Domestic Relations Law, the Governing Body of any village, town or city may appoint one or more marriage officers who shall have the authority to solemnize a marriage within the territorial jurisdiction of such municipality and which marriage shall be valid if performed in accordance with other provisions of law; and

**WHEREAS**, Sharon Natalie Abramski, Village Clerk-Treasurer, has requested the Village Board to appoint her to the position of Marriage Officer; and

**WHEREAS**, Sharon Natalie Abramski is a resident of the Village of Manorhaven over eighteen years of age and thus meets the qualifications for serving as a Marriage Officer set forth in Section 11-c of the Domestic Relations Law;

**NOW, THEREFORE, BE IT RESOLVED THAT:**

1. The Village Board of the Incorporated Village of Manorhaven appoints Sharon Natalie Abramski, as a Village of Manorhaven Marriage Officer, for a term expiring on July 11, 2019, or until such time as her appointment may be withdrawn pursuant to Domestic Relations Law Section 11-c; and
2. The Marriage Officer shall receive no salary or wage. She is authorized to accept and keep up to seventy-five (\$75.00) dollars for each marriage that she officiates, to be paid by or on behalf of the persons married; and
3. The Marriage Officer may solemnize marriages within the territorial jurisdiction of the Incorporated Village of Manorhaven; and
4. The terms of this Resolution shall take effect immediately.
