**Local Law 21 of 2017**

A local law amending Village Code Chapter 146 (Vehicles, emergency repair of), by adding Section 146 - 2 (Maintenance or repair in yard or buildings restricted) to require certification by the NYS Department of Motor Vehicles, or the County of Nassau, of certain commercial auto repair activities in yards or buildings; and Section 146 - 3 (Penalties for offenses) to fix the fine for violations of Chapter 146 at an amount established by resolution of the Board of Trustees.
