**LOCAL LAW** amending Chapter 147 (Vehicles and Traffic), Article III (Parking, Stopping and Standing), by adding Section 147-22.2 to reserve certain parking spaces for use by motorcycles only; amending Section 147-33 (Penalties for offenses) to establish a penalty for noncompliance with Section 147-22.2; amending Section 147-33.1 (Penalties for late payment) to establish a penalty for late payment of a penalty imposed pursuant to Section 147-33; amending Section 147-41 (Stop intersections) to designate as a stop intersection Cambridge Avenue at Cottonwood Road; and adding Section 147-54 to identify certain parking spaces reserved for use by motorcycles only.

# 7. BOARD OF TRUSTEES – INC. VILLAGE OF MANORHAVEN - July 28, 2016 RESOLUTION #62 TO AUTHORIZE MOTORCYCLE PARKING ONLY

WHEREAS, the Board of Trustees is authorized by New York State Vehicle and Traffic Law Article 39 (Regulation of Traffic by Cities and Villages), Section 1640, to establish parking regulations; and WHEREAS, Local Law 8 of 2016 provides that the stopping, standing or parking of a vehicle in any location designated as a place for motorcycle parking only described in Schedule XVIII (§147-54) is prohibited, unless the vehicle is a motorcycle, as that term is defined by the New York Vehicle and Traffic Law as amended from time to time; and

**WHEREAS**, Local Law 8 of 2016 further provides that the stopping, standing or parking of a vehicle in the locations described below, which are hereby designated as places for motorcycle parking only, is prohibited, unless the vehicle is a motorcycle, defined as a vehicle having a seat or saddle for the use of the rider and designed to travel on not more than three wheels in contact with the ground, but excluding a tractor.

Juniper Road North Adjacent to 35 Juniper Road

Firwood Road East Between 56A and 58 Firwood Road

**NOW, THEREFORE, IT IS HEREBY RESOLVED** that the Clerk is hereby directed to cause appropriate signs to be erected at the designated locations stating that they are reserved for motorcycles parking only, and containing such other information as may facilitate enforcement of the parking regulation.

WHEREAS, the Board of Trustees is authorized by New York State Vehicle and Traffic Law Article 39 (Regulation of Traffic by Cities and Villages), Section 1640, to establish traffic regulations; and WHEREAS, in accordance with the provisions of §§147-12 and 147-44 of the Village Code, trucks are excluded from all streets in Manhasset Isle except Secatoag Avenue, Matinecock Avenue, Sintsink Drive East south of Manhasset Avenue, and Sagamore Hill Drive between Secatoag Avenue and Matinecock Avenue (collectively, the "Manhasset Isle Truck Route"); and

**WHEREAS**, the signs indicating the Manhasset Isle Truck Route are deteriorated due to their age and exposure to the elements; and
