I look forward to and happily anticipate our next two years together. Manorhaven is now safer, stronger and more secure than it was two years ago. In the next two years, we will begin some major initiatives that will continue and further expand the progress that has taken place.

In June, we began a very important initiative for our Village - the formation of a ***Manorhaven Business Revitalization Committee***. While all Long Island towns and villages have been affected by business downturns, Manorhaven has a special asset - our beautiful surrounding waterfront that draws both businesses and consumers to our Village. We are a unique Village and our business community is an important part of it. The purpose of the Committee is to implement ways to support existing Manorhaven businesses and bring new business into the area. Please see our *Spotlight on Business* page.

We have also begun our ***Three-Year Capital Plan*** for Manorhaven. The purpose of this plan is to assess with our departments the major needs of our Village over a three year time frame and to fiscally plan ways to meet these needs. We have listened to our residents input and that will play an important part in deciding and prioritizing our goals. The needs being considered include roads, infrastructure, equipment and more. To meet this, we will utilize and explore CHIPS funding, grants, bonds and other venues. We have begun this capital plan to secure property values, provide business support, insure resident safety and improve Manorhaven's quality of life.

As you know, a beautiful nautical gazebo was recently built at *Morgan's Dock* at Bowman's Point Road - we were able to make our promise a reality. On June 28th, we held a gathering at Morgan's Dock where residents could view future plans and ask questions. We were especially happy that Ben Morgan's granddaughter and great-grandson attended. Please see the article and photos in this newsletter. Morgan's Dock is important to our community in immeasurable ways: preserving waterfront land for our village, creating an enjoyable waterfront park-like setting and dock for residents, and aiding our business community through marine use and tourism. Recently, an article in Newsday featured our wonderful project. More Importantly, the funding to revitalize Morgan's Dock was secured almost entirely by grants. We are awaiting additional grant funding to move forward with this project. We will be reporting to residents as the restoration progresses.

We also have had a number of staff and trustee changes at our Village. We wish our former Village Clerk Liz Gaynor the best in her new position as Clerk for the Village of Sands Point. She has been a highly dedicated and caring member of our staff for these past two years and we will truly miss her. We are very pleased and very fortunate that Leslie Gross - former North Hempstead Town Clerk has taken the position. With Leslie's wealth of expertise and experience, Manorhaven's Village office is in excellent hands. Additionally, we were sad to lose two of our wonderful and caring Trustees, Dorit Zeevi-Farrington and Mark Lazarovic. In every decision they made, the best interests of all our residents were always in their minds and in their hearts. We look forward, however, to their dedication continuing for our Village as they remain an active part of our community. We welcome our two new Trustees - Priscilla von Roeschlaub and Kevin Gately. We are very fortunate and happy to have Drew as a member of our Village government and to have him assist us in implementing new and additional Health & Safety measures for Manorhaven:

The following are some important **EMERGENCY** reminders from Commissioner HaagenSON:

- Keep a working transistor radio handy for A.M. news and information updates;
- Keep battery operated lanterns and or flashlights. LED bulbs are best because they are long lasting;
- Do not use candles - they are fire hazards;
- Cell phones are unreliable during some emergencies due to network problems and the inability to charge them;
- Keep a five gallon jug as well as individual bottles of water available. This is the most important item you can have;
- Keep fresh canned or dried food on hand;
- Keep an emergency supply of current unexpired medications available;
- Check on elderly and disabled relatives and neighbors;
- Only summon emergency help for true emergencies. If you can get yourself or someone else to a hospital do so. Ambulances should be reserved for those who cannot transport themselves.

LEARNING ABOUT OUR PUMP STATION

Manorhaven’s Pump Station located at the corner of Pequot Avenue and Sintsink Drive West, helps keep our community in the flow. Manorhaven maintains its own pump station and two years ago when we took office, we began a major overhaul of this antiquated structure. On August 14th, Bruno D’Aversa gave a tour of the pump station to new trustees, Priscilla Von Roeschlaub and Kevin Gately who were unfamiliar with the pump station location, upgrades and its workings. Our DPW crew has been maintaining the pump station for the last 15 years under the supervision of Bruno D’Aversa. The Mayor and Joe Giunta, long time Manorhaven residents, were instrumental in implementing recent upgrades to the station and we are proud to say that our station is now working at 100% capacity! One of the biggest remaining projects is to replace the original force main which was installed in approx. 1956. We are currently researching ways to accomplish this. Upgrades since 2012 include the following: the relocation of the suction valve on Pump #3; the installation of a new 24 hour security alarm notifying our DPW of failures (This system was installed by Bruno’s son Luigi D’Aversa who also updated electrical panels at that time.); the addition of a new sump pump to the drywell and a sump pump panel; the rebuilding of pumps #1 and #2 pumps; the purchase of a new replacement pump; the replacement of the compressor that serves the bubbler system controlling pressure switches to the pumps; the replacement of the oil tank; the cleaning of the entire wet well (This had not been cleaned since its refurbishment approx. 30 years ago.); the replacement of the grinder macerator a/k/a the “Muffin Monster;” the installation of a new wet well fan; and the purchase of a safety meter for confined spaces. Bruno D’Aversa has a long history in the pump business; he was the foreman for all of the pump stations with Port Water Pollution Control for 22 years. We are extremely fortunate to have him assisting us with the Pump Station.

CODE ENFORCEMENT NEWS - KAREEM BUCKLEY



We have recently observed large bulk items being incorrectly discarded for pick up by our residents. Please be aware that **ALL** bulk items must **FIRST** be scheduled for a pick up with Meadow Carting **BEFORE** being placed by the curb. If bulk items are not placed in a neat and safe manner, or are haphazardly placed in front of homes, they may pose a threat to other residents. We will immediately issue an ‘Order to Remedy’ when such occurrences take place and if not corrected, the warning will be followed by a ticket and fine. Meadow Carting has been very conscientious and responsive regarding bulk pick ups as they make every effort to accommodate residents and our Village. It is important that each resident does their part to keep our Village orderly and safe. We would appreciate everyone’s cooperation in disposing of trash in the appropriate manner. 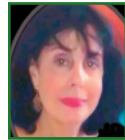


SPOTLIGHT ON BUSINESS



A NOTE FROM DEPUTY MAYOR STEELE

Dear Friends & Neighbors,



As the Board’s liason to our newly formed Manorhaven Business Revitalization Committee, I am writing you to tell you about its mission and what we have already begun. Just before re-election, we instituted a Manorhaven Business Revitalization Committee to support the Manorhaven’s business community. This initiative is in response to the economic downturn taking over our once vibrant and now stagnant Long Island downtowns. Proactively, at the June BOT, we appointed six highly respected community business owners to head the Committee. At the initial August 4th and 11th meetings, we began work on a number of ideas:

- Clerk Leslie Gross will be instrumental in creating a Manorhaven brochure of vital information that will contain local business coupons;
- Our newsletter will feature a *Spotlight on Business* page for new and existing businesses;
- We will distribute local shopping cards entitling residents who shop locally to discounts and/or free services and merchandise;
- Deputy Clerk Sharon Natalie will help us create a Manorhaven map featuring local businesses with business advertisers;
- New residents will receive a resident packet containing all of the above as well as other pertinent Village information;
- Village beautification and safety: solar lights around the Dog Park and Preserve with CCTV monitors with clearing and cleaning of open spaces, plantings near curbs, flags on light posts, hanging flowers, and diagonal parking in business areas;
- We are exploring ways to make Manorhaven a **destination**. Dennis Parisi is researching a miniature golf course in Manorhaven. Possible options and sites have been discussed;
- We are also working on ways to utilize our newest greenspace, Morgan’s Dock, to maximize business revitalization.

We will soon be holding an open meeting for the entire business community to exchange ideas on the best ways to support local businesses, serve residents and keep our Village fiscally sound. They have been amazing sources of expertise, support and help for our community, as well as a wonderful part of our team. Their increasing personal workloads no longer allow them to continue in their roles as Commissioners. They will be greatly missed, however, we know they will continue to be concerned members of our community. We wish them well in all their endeavors and are so pleased to always have them as our neighbors and friends to the Village.

Michelle Roper will be filling in for Bob. Michelle was with the EPA from 1988 to 1992. She worked at the EPA on The Resource Conservation and Recovery Act and was in the Hazardous Waste Division. Michelle also worked as an EPA consultant from 1992 to 1998 helping the regulated community to comply with environmental laws. Additionally, she was instrumental in aiding the Village of Waimanalo in Hawaii to implement a storm water runoff program in order to keep pollutants out of streams which empty into the ocean. Michelle is a strong advocate of sound environmental practices. She has a special concern for our Community and desire to serve Manorhaven and preserve its natural resources. With serious issues facing our community: ongoing oil spills in our wetlands, maintaining our waterways and waterfront, improving and maintaining our green spaces and supporting our infrastructure, this position is vital to our community. We would like to extend a very warm welcome to Michele and give her our thanks for caring so much about Manorhaven's unique and beautiful environment. STORM WATER POLLUTION PREVENTION IS UP TO US - MICHELLE ROPER

In Manorhaven, runoff from rain storms and snowmelt flows directly to Manhasset Bay with NO treatment. Pollution of storm water is a serious problem for wildlife and for the people who live near the Bay or use it for recreation. Some common pollutants in storm runoff include spilled oil, fuel, and fluids from vehicles and heavy equipment; construction debris; pesticides or weed killers; materials such as motor oil, antifreeze and paint products that people pour or spill into a street or storm drain.

Pet wastes are also a serious problem. Manorhaven is working with citizens and businesses to clean up storm water runoff. We hope you will join us by keeping pet wastes out of Manhasset Bay. **PET OWNERS BE CAREFUL!** When you clean up after your pet, do you dump the waste in the street or storm drainage system? Do you leave waste to decay on the sidewalk or on the grass near the street? If so, you may be causing pollution or health problems. Pollutants from improperly disposed pet waste may be washed into the Bay. The waste decays using up oxygen and sometimes releasing ammonia. Low oxygen levels and ammonia combined with warm temperatures kill fish. Pet wastes also contain nutrients that encourage weed and algae growth. Overly fertile water becomes cloudy and green which is unattractive for swimming, boating and fishing.

Perhaps more importantly, pet waste can carry diseases which could make water unsafe for contact. Some of these diseases are:

Campylobacteriosis - bacteria infection; ***Salmonellosis*** - bacteria infection; ***Toxocariasis*** - roundworm infection
Toxoplasmosis - protozoan parasite infection; ***Giardiasis*** - protozoan parasite infection.

WHAT CAN YOU DO? Use a plastic bag or pooper scooper on your walk, flush waste down the toilet or put waste in the trash after securely closing the bag. **DO NOT COMPOST WASTE** Let's all work together to keep pet waste out of beautiful Manhasset Bay. The beauty and life of Manorhaven is our home.

LOOK FOR THIS SYMBOL ON OUR STORM DRAINS

We are hoping to create community awareness with these "No Dumping Drains to Bay" stencils on Manorhaven storm drains. Many people assume that these drains flow into "treatment" facilities, but in reality, they flow directly into our Bay. We hope to alert people that NOTHING should be dumped into drains. Untreated material can pollute our community waterways.



A DAY AT THE GAZEBO

On June 28th, residents were invited to stop by Bowman's Point to see our beautiful new nautical Village gazebo, view future plans, and ask questions about the continued restoration of Morgan's Dock. Residents came by to enjoy the warm June day, have an ice cream or a grilled cheese sandwich and lemonade, but most of all to chat with us and fellow neighbors. Many long time residents shared memories of the dock and its adjacent restaurant, The Harbor Inn. Some neighbors purchased books from our resident historian Dolly Larson. Everyone was excited to learn more about the restoration. One of the most memorable moments was when Ben Morgan's granddaughter and great-grandson for whom the Dock is named, came by to speak with us. The history of Morgan's Dock is a saga about how a once thriving vital marina and ferry service owned by Ben Morgan came into disuse and disrepair after years of governmental issues and changes in transportation. We are awaiting the acceptance of a second grant due in September complete seating, plantings, lighting, fencing and signage. We would especially like to thank Trustee Rita DiLucia, whose ongoing work on the Morgans' Dock Project provided the groundwork toward its creation. Our Deputy Clerk-Treasurer, Sharon Natalie has been on top of the grant process every step of the way. It is rewarding to know that things have finally come full circle and after decades.
