

**VILLAGE OF MANORHAVEN

PUBLIC NOTICE**

A public hearing will be held by and before the Board of Trustees of the Incorporated Village of Manorhaven, New York, at the Manorhaven Village Hall located at 33 Manorhaven Boulevard, in Manorhaven on **Thursday, March 23, 2017 at 7:00 p.m.** The monthly Board meeting will immediately follow the hearing. **The Board will hear and consider:**

**A local law** amending Village Code Chapter 4 (Appearance Tickets), Section §4-6 (Issuance for vehicle and traffic offenses), by adding subsection C, to authorize such member or members of the Board of Trustees as may be designated from time to time by resolution of the Board of Trustees to issue appearance tickets returnable in the Village Justice Court pertaining to the enforcement of any and all provisions of the Village Code relating to parking violations committed during the effective period of snow emergencies as set forth in Village Code §147-25.

**A local law** amending Village Code Chapter 38 (Building Code Administration) amending Section 38-10 (Operating permits) A(1)(d) to require operating permits for Buildings containing one or more areas of public assembly with an occupant load of 50 persons or more.

**A local law** amending Village Code Chapter 120 (Rental Housing), Section 120-17 (Penalties for offenses), to fix the fine for violation of Section 120-3 (Permit required) at an amount equal to twice the then current permit fee payable pursuant to Section 120-14 (Schedule of fees).

**A local law** amending Village Code Chapter 155 (Zoning), Section 155-68 (Penalties for offenses) to fix the fine for violation of Section 155-43 (Storage and parking of certain vehicles), Subsection B, at an amount established by resolution of the Board of Trustees.

**A local law** amending Village Code Chapter 132 (Streets and sidewalks), Section 132-15 (Penalties for offenses), to fix the fine for violation of Section 132-9 (Snow and ice removal) at an amount established by resolution of the Board of Trustees.

**A local law** amending Village Code Chapter 155 (Zoning), Section 155-20 (Commercial Retail and Sales Stores, C-3 District) to limit the permitted hours of operation of retail stores, retail shops and trade stores to the hours between 6:00 a.m. and 10:00 p.m.

**A local law** amending Village Code Chapter 138 (Building Code Administration) Section 138-4 (Building permits) to limit the permitted hours of construction activities to the hours between 8:00 a.m. to 6:00 p.m. on weekdays, and between 9:30 a.m. to 5:00 p.m. on Saturdays.

Copies of the said proposed local laws are on file at the office of Village Clerk and may be viewed during the hours of 8:30 a.m. to 4:00 p.m., Monday through Friday. If any individual requires special assistance to attend, please notify the Village Clerk at least 48 hours in advance of the hearing.
