# VILLAGE OF MANORHAVEN BOARD OF TRUSTEES REGULAR MEETING THURSDAY, OCTOBER 23, 2014 7:30 pm

The regularly scheduled Board of Trustees meeting was called to order at 7:30 pm by Mayor Giovanna Giunta. The Mayor asked Mr. Bruno D'Aversa to lead those assembled in the Pledge of Allegiance. Roll was called with the following in attendance:

The Clerk noted for the record that draft minutes were sent to all Trustees by the Deputy Clerk two weeks prior, on October 9th. All Board members concurred. Please note that only Trustee Gately abstained from voting on the minutes on the basis of not having time to review same. The packet was sent to all Board members on October 23<sup>rd</sup> at 10:25 am for review, nine hours before the BOT meeting. Mr. Gately then requested items be sent to him during the month when they are proposed for placement on the agenda even if they don't appear on the final agenda.

Trustee Di Lucia made a motion to approve the minutes of the September 17, 2014 meeting as presented. Deputy Mayor Steele seconded the motion.

Deputy Mayor Steele talked about the expenditure to TAPCO of two new Solar Powered Stop Signs as traffic calming measures which have been requested by many residents who complain of drivers speeding throughout the Village. The Clerk added that the cost of these signs will be presented to CHIPS (The <u>C</u>onsolidated Local Street and <u>Highway Improvement Program</u>) for reimbursement. CHIPS funds are disbursed to municipalities to support important maintenance and repairs of local roads, signage etc.

#### PUBLIC COMMENT

\* Patrick Gibson stood and voiced his opinion that people should be able to remove as many trees as they like from their own property.

\* Barbara Faticone asked The Village to review some of the street signs in the Village. She showed the Board photos of her street, Sintsink East, where several of the signs, though legible seemed difficult to understand. Mr. Faticone added that people park to the corner which obstructs vision. He is concerned about speeding on that block.

\*Mr. Avena requested the Village provide more information about all of our expenses, though each check appears on the abstract. Mr. Toner added that The Village will now be better served because we have hired a stronger municipal accounting firm. Trustee Steele added that she is working with our new accounting firm to develop a three-year capital plan.

\*It was noted by The Mayor that the "No Through Commercial Traffic" sign on Dunes Lane (which the Village had replaced) was stolen again.

\*With winter coming, Mr. Orr commented on landlords who don't clean their property properly in a snowstorm. The Mayor cautioned that it is not all landlords, and that our code enforcers are vigilant about keeping the sidewalks etc. as safe as possible. We also want to investigate what we can to help seniors who can't shovel their own property.

\*Linda Dlugolecki asked that residents be aware of their overgrown shrubs that extend over the sidewalk. Building Superintendent Abramski said this particular sidewalk was taken care of two days prior to the meeting.

The next meeting of the Board of Trustees will be held on November 20, 2014 at 7:30 pm. The Mayor reminded everyone that Election Day is November 4<sup>th</sup> and Village Hall will be closed on that as well as Veteran's Day, November 11<sup>th</sup>. The Board joined in thanking all of our Veterans for their service.
