RESOLUTION NO. 78 - AUGUST 27, 2009 A RESOLUTION AUTHORIZING THE VILLAGE CLERK-TREASURER TO SEEK COMPETITIVE BIDS

BE IT FURTHER RESOLVED, that upon the recommendation of Commissioner of Trees, Trustee John M. DiLeo, Jr., and consistent with the standards set forth in section 143-4(C) of the Code of the Inc. Village of Manorhaven, permission be and hereby is granted to JoAnn Wilson, having an address at 52 Hickory Road, Port Washington, NY, for removal of one (1) tree located at said premises; and

BE IT FURTHER RESOLVED, that upon the recommendation of the Commissioner of Trees, Trustee John M. DiLeo, Jr., and consistent with the standards set forth in section 143-4(C) of the Code of the Inc. Village of Manorhaven, permission be and hereby is granted to Sergio Tejeda, having an address at 93 Edgewood Road, Port Washington, NY, for removal of two (2) trees located at said premises (including the large silver maple tree and locust tree, but excluding the tulip tree); and

BE IT FURTHER RESOLVED, that the permit fees to be charged to the property owners, as set forth in section 143-6 of the Code, be and hereby are waived; and

BE IT FURTHER RESOLVED, that the provisions of this Resolution shall take effect immediately.
