A Message from Mayor Giunta

Dear Residents:

Summer has been a time of ongoing projects for our Village. We are currently finishing up safety and quality of life issues that needed addressing, but of

special concern to us has been the filing of a number of grants that will help provide our Village with much needed services and projects which are listed below. In addition, We would like to thank our new carting company, Meadow Carting who has provided excellent service to date at a substantial savings to our Village. Many of our residents have voiced their satisfaction with the new carting company.

IMPORTANT FINANCIAL UPDATE:

We are extremely happy to report that to date, we have received a reimbursement of \$547,936 from FEMA and are awaiting additional reimbursements from New York State. The monies, in their entirety, have been allocated by our accountants to pay back the bonds on their maturity date of February 27, 2014. Despite the severity of the storm, we can report that it did not result in a financially detrimental situation for our Village. We are very grateful to the competence of our Village Clerk, Liz Gaynor and our forensic accountants whose diligence and hard work helped make this a successful financial outcome for the Village.

ADDITIONAL UPDATES:

- The new Pump Station alarm system has been installed and is providing needed safety for our system, the wet well has been thoroughly cleaned in order to keep it running smoothly, the yard was cleaned, and Pump #1 has been rebuilt at the Pump Station;
- Two solar stop signs were installed on Manorhaven Blvd. in response to resident concerns;
- A new crosswalk on Manhasset Isle will be added at the corner of Manhasset Ave and Pequot for improved visablility, and two additional streetlights were installed in Manhasset Isle;
- Join us for our new Dog Park ribbon cutting on September 28 at 11 a.m., the 9-11 Ceremony at Village Hall at 5 p.m. and our October Street Festival on October 5 from 11 a.m. to 4 p.m.
- Fourteen replacement trees were planted and our arborist suggests that any additional trees be planted in the fall;
- Our Highway Department has been diligently addressing potholes throughout the Village;
- We are completing handicap ramps, which have been reimbursed in their entirety by the CHIPS Capital Reimbursement Program;
- The Superintendent of Buildings has been reviewing and working on updating Village Codes;
- We were recently awarded a \$75,000 grant for Morgan's Dock from the Community Development Block Grant and are currently applying for additional funding from other sources. We expect work to begin this fall;
- Through a reinstatement of a \$50,000 Community Capital Assistance Grant, we have been approved for the renovation of our administrative offices updating wiring, flooring and insulation;
- Our new Planning Board has been very active in formulating a comprehensive vision plan and pro-active implementation of it for Manorhaven. We will keep residents informed.

I hope the end of Summer brings you and your families relaxing and happy times.

EQUALIZING VILLAGE TAXES

Manorhaven recently raised commercial property taxes in order to right a seven year tax inequity on its residents. Throughout not only Long Island, but throughout most of our states, residential tax rates are lower than commercial tax rates. Mineola resident taxes are 60% lower than commercial rates. Russell Gardens resident taxes are 55% lower than commercial taxes. However in Manorhaven, residential taxes were actually 93% higher than commercial tax rates. Between 2005 – 2012, Manorhaven residential tax rates rose from 20.3% to 134.1%, a whopping 560% increase, while commercial rates increased only 9%. Between 2006 – 2010, Manorhaven's commercial tax rates actually went *down* for five years - in fact – commercial rates were decreased by 24.8%. In 39 states, residental taxes are lower than commercial taxes, in 9 states they are equal. Only in 4 states were residential rates slightly higher than the commercial tax rates. Manorhaven's tax rates were clearly the opposite of other Long Island communities and most of the country's.

This inequity placed the overwhelming tax burden squarely on the shoulders of our residents. In response to this inequity, and after extensive deliberation with our accountants, we held a public hearing and passed a resolution allowing us to raise only commercial taxes above the 2% constitutional tax limit. We support and are concerned about our commercial property owners, but believe the increased revenue will benefit them as well. On average, our commercial property owners have seen an increase of \$1,790 a year in their tax bill based on the assessment. This equalizing of property tax rates is justified because of years of inordinately low commercial tax rates, and is especially justified for our large commercial properties that utilize a larger percentage of our Village resources, and benefited most from significantly lower taxes over the last ten years. Furthermore, by not collecting these taxes before, the Village gave up much needed and significant revenue that could have been used all along to improve our roads and increase Village services for both residential and commercial property owners. This increased revenue will rebuild our Village cash reserve to safeguard us from future financial hardship, and hopefully lower residential taxes in the future. Below you will find charts that includes the above-noted information.

RESIDENT QUESTIONS...VILLAGE ANSWERS

O. SHOULD THERE BE A MONTHLY NEWSLETTER?

A. A quarterly newsletter is mailed out to every resident in Manorhaven and is posted online under "Village News." The expense of a monthly newsletter would be an unnecessary cost to the Village. However, in lieu of that, our Village website is continually updated as needed on a daily, weekly, or monthly basis with all current events and information. Additionally, all past issues of the Quarterly newsletter can be found online under "Village News."

Q. WHAT IS HAPPENING WITH POTHOLES & SIDEWALKS?

A. We have been assessing all potholes and sidewalks. We appreciate your calls to Village Hall to report those of concern to you. As much as we would like to repave all roads immediately, it is an extensive project with many budgetary concerns that we are addressing. However, residents may have noticed that the Highway Department has repaired many of the potholes on the Manorhaven Blvd. side of the Village and in Manhasset Isle. It is important to note that the maintenance of Manorhaven Blvd. is the sole responsibility of Nassau County and sidewalks along Manorhaven Blvd. next to the Town Pool are maintained by the Town of North Hempstead. Storefront sidewalks are the responsibility of the business owner and sidewalks in front of residential property are the responsibility of the home owner. We thank you for your patience as we continue to move forward.

O. WHAT CAN BE DONE ABOUT TRAFFIC NEAR THE POOL?

A. In addition to requesting increased police monitoring, we have recently installed two solar stop signs near the pool to increase safety for adults and children in this high traffic area. In order to do so, we had to pass a resolution since this road is not under our Village jurisdiction. You may have also noticed new stop lines to increase night time and poor weather visibility and we are planning a new crosswalk on Manhasset Ave. Our resident's safety is our prime concern.

Q. WHAT IS BEING DONE ABOUT STRAY SHOPPING CARTS?

A. Whenever we notice carts, or they are brought to our attention, we immediately send out the Highway Department to remove them. We do ask that all residents **please refrain** from bringing home shopping carts. They pose a real walking and potential traffic hazard to all our neighbors, and are unsightly in our beautiful neighborhood. Be informed that this is illegal, and violators that are caught will be subject to a fine by our Village Code Enforcer. We thank you for your cooperation.

Q. WHO NEEDS A RENTAL REGISTRATION?
