## RESOLUTION NO. 30 - APRIL 3, 2009

A RESOLUTION AUTHORIZING AND DIRECTING THE VILLAGE CLERK TO ADVERTISE FOR COMPTEITIVE BIDS PURSUANT TO SECTION 103 OF THE GENERAL MUNICIPAL LAW

Deputy Mayor Brostowin offered the following resolution, seconded by Trustee Fahey:

WHEREAS, on May 28, 2008, the Inc. Village of Manorhaven (the "Village") entered into a contract for the collection and disposition of solid waste within the Village, for the period June 1, 2008 through May 31, 2009; and

WHEREAS, said contract sets forth, at numbered paragraph 2, a provision requiring that notice from the Village be provided in the event the Village determines to extend such contract beyond said date of May 31, 2009; and

WHEREAS, such notice was not provided by the Village; and

WHEREAS, it is an essential function of the Village to provide for the orderly collection and disposition of solid waste within the Village; and

WHEREAS, the present contract with respect to the collection and disposition of solid waste within the Village will end, by its own terms, effective May 31, 2009;

NOW, THEREFORE, BE IT RESOLVED, that the Village Clerk be and hereby is authorized and directed to advertise for competitive bids, pursuant to Section 103 of the General Municipal Law, for the collection and disposition of solid waste within the Village, for the period June 1, 2009 through May 31, 2010, and for four (4) additional one (1) year periods, at the sole option and discretion of the Village; and

BE IT FURTHER RESOLVED, that the provisions of this Resolution shall take effect immediately.
