the Manorhaven Planning Board to matters transferred by the Board of Trustees. Proposed local law shall also impose the duty of the Planning Board to review and make recommendations on site plans to the Board of Trustees. The proposed local laws are a transfer of authority from the Planning Board back to the Board of Trustees.

At this time Mayor Giunta stated the Board of Trustees undertook a responsible independent zoning study to access the Village needs. The study was presented and explained to our residents at a Village meeting. The Village will be benefiting with the revitalization effort. Mayor Giunta stated we are not voting on items tonight, we are here to listen to the opinions and get feedback from our residents.
