RESOLUTION #18-2022 A RESOLUTION ACCEPTING A PROPOSAL FOR MILLING AND PAVING OF VILLAGE ROADWAYS UNDER THE TOWN OF NORTH HEMPSTEAD BID, DPW PROJECT NO.19-01

WHEREAS, the Town of North Hempstead, being a political subdivision of the State of New York, duly engaged in competitive bidding in compliance with the requirements of the General Municipal Law and approved a contract thereunder with Posillico Civil, Inc., having its principal office at 1750 New Highway, Farmingdale, NY 11735 (the "Contractor") for On-Call Services for Milling and Paving Town Roadways, DPW Project No. 19-01, by Town Board resolution no. 146-2019, and said award of contract having been extended through December 31, 2022 by Town Board resolution no. 97-2022; and

WHEREAS, said award of contract provides that pursuant to General Municipal Law §103(16), such contract may be utilized by any governmental entity in New York State; and

WHEREAS, the Village has provided said Contractor with the report of Cameron Engineering & Associates, LLP (the "Village Engineer") setting forth a list of Village roadways in need of repairs, and the Contractor has provided a proposal for milling and paving certain Village roadways as prioritized by the Village Engineer; and

WHEREAS, the Village has received a certain proposal dated March 21, 2022 (the "Proposal"), from said Contractor, proposing Asphalt Milling and Paving for milling and paving the following primary scope of work:

- 1. Edgewood Road from Manorhaven Boulevard to Ashwood Road, consisting of approximately 6,767 square yards of area,
- 2. Ford Place from Firwood Road to Dunwood Road, consisting of approximately 1,418 square yards of area;
- 3. Inwood Road from Cambridge Road to the dead end, consisting of approximately 3,934 square vards of area:
- 4. Kirkwood Road from the intersection of Cambridge Avenue approximately halfway to the dead end, consisting of approximately 1,492 square yards of area; and

WHEREAS, said road improvements total approximately 13,611 square yards of area milled at the rate of \$3.35 per square yard for milling (\$45,596.85), and requiring approximately 1,512 tons of asphalt at the rate of \$80.00 per ton (\$120,986.65); and

WHEREAS, said Proposal also includes one alternate roadway: Linwood Road North from Manorhaven Boulevard to the dead end, consisting of approximately 5,129 square yards of area milled at \$3.35 per square yard for milling (\$17,182.15) and requiring approximately 570 tons of asphalt at the rate of \$80.00 per ton (\$45,600.00);

NOW, THEREFORE, BE IT RESOLVED, that the Inc. Village of Manorhaven accepts said Proposal for the primary scope of work at a cost not to exceed \$166,583.50; and

BE IT FURTHER RESOLVED, that the Mayor is hereby authorized to sign such documents as may be necessary to accept said Proposal; and

BE IT FURTHER RESOLVED, that the provisions of this resolution shall take effect immediately.

RESOLUTION #19-2022 A RESOLUTION MAKING A TEMPORARY APPOINTMENT

CALL TO ORDER: 6:30 p.m.

PLEDGE OF ALLEGIANCE: Debbie Greco

ATTENDANCE: Present: Mayor Jim Avena, Deputy Mayor Rita Di Lucia, Trustee Harry Farina (via Zoom), Trustee John Popeleski, Trustee Vincent Costa, Alex Kovacevic, Deputy Village Clerk, Jonathan Fielding, Esq., Village Attorney; Excused: Joanie Corbo Hanna, Esq., Village Clerk

GROWING LOVE COMMUNITY GARDEN CERTIFICATE OF RECOGNITION: Mayor Avena and the Board of Trustees presented the Growing Love Community Garden with a Certificate of Recognition from the Village for their charitable works benefitting the Village.

<u>VILLAGE BUSINESS UPDATE:</u> Mayor Avena provided an update on the Village's plans for road paving and funding. Deputy Mayor DiLucia provided an update regarding the Nature Pathway Project, further noted that a formal application was submitted to the Department of Environmental Conservation. Trustee Popeleski reported on concerns regarding the flooding, grading, and drainage on Orchard Beach Boulevard. Referred to recent observational meeting held on Orchard Beach Boulevard with Cameron Engineering. Trustee Costa reported that the Village proposed tree planting would soon begin.
