LOCAL LAW #3-2023

RESOLUTION NO. 59 - APRIL 26, 2023

A RESOLUTION DIRECTING THE AMENDMENT OF CHAPTER 120. RENTAL HOUSING, Sec. §120-16. PROHIBITED CONDUCT. §§ A, B.; and § 120-17. PENALTIES FOR OFFENSES.

WHEREAS, it appears that the Village of Manorhaven is desirous of regulating short term rentals within the Village of Manorhaven which impact on the quality of life for the residents of the Village and protect the safety, health and welfare of the residents as well as the inhabitants of the short term rental units; and WHEREAS, Municipal Home Rule Law Section 10, authorizes the Village to adopt a local law which amends or supersedes any provisions of the Village Law in relation to the property, affairs or government, terms of office of the Village or in relation to any of the other enumerated subject matters in Section 10, unless there is a legislative restriction on such amendment or supersession; and

WHEREAS, it is in the best interest of the Village of Manorhaven to maintain and regulate the area and keep the area and residents safe; and so to do, it is

NOW, THEREFORE, BE IT RESOLVED, that the Incorporated Village of Manorhaven determines that the Local Law No. 4-2006, is amended and CHAPTER 120. "RENTAL HOUSING, 120-16. "PROHIBITED CONDUCT. A. B."; and § 120-17. "PENALTIES FOR OFFENSES. §§ A. B.", is hereby amended and superseded in its application to the Incorporated Village of Manorhaven, and shall be replaced with the following and read as follows:

Chapter 120. RENTAL HOUSING.

Sec. §120-16. Prohibited Conduct.

A. It shall be unlawful and a violation of this Chapter and an offense within the meaning of the New York State Penal Law, for any person to list, solicit, advertise or offer, exhibit or show, to any person, a dwelling unit within the Village, for the purpose of bringing about or causing the rental thereof, where no currently effect permit has been issued by the Superintendent of Buildings in respects to such dwelling units, as provided in this Chapter.

B. It shall be unlawful and a violation of this Chapter and an offense within the meaning of the New York State Penal Law, for any person to list, solicit, advertise or offer, exhibit or show, to any person, a dwelling unit within the Village, for the purpose of bringing about or causing the Short-Term Rental thereof for a time period of less than six (6) months either concurrently or consecutively as provided in this Chapter. § 120-17. Penalties for Offenses.

[Amended 3-23-2017 by LL No. 4-2017]

- A. Any person who violates, facilitates, or assists in the violation of, any provision of this Chapter other than § 120-3 (Permit Required) shall be guilty of a violation punishable by a fine not exceeding \$1,000 or imprisonment for a period not to exceed 15 days, or both, for conviction of a first offense; for a conviction of a second offense, both of which were committed within a period of two years, punishable by a fine of not less than \$1,000 nor more than \$2,000, nor more than \$3,000 or imprisonment for a period not to exceed 15 days or both. Each week's continued violation shall constitute a separate violation of this Chapter.
- B. Any person who violates, facilitates, or assists in the violation of § 120-3 (Permit required), shall be guilty of a violation punishable by a fine in an amount equal to twice the then-current permit fee payable pursuant to § 120-14 (Schedule of Fees). Each week's continued violation shall constitute a separate violation of this Chapter.
